## **Topic: The Children's Aid Society (CAS) and family courts**

In recent years there has been growing public criticism and debate surrounding the harm being done to children and families by Children's Aid Agencies and the family courts. While much of the harm is being done by authorities in secret and out of the public eye, an increasing number of children and family members are now reporting how their families have been the subject of persecution and abuse by the CAS and the family courts. During the summer of 2010 there were two public protests in Huntsville with more planned for next year by groups promoting accountability and transparency with CAS and the family courts.

As more and more families become adversely affected by the economic slowdown they are being targeted by Children's Aid Agency workers who are tearing families apart and then taking their children away from them. The actions of the CAS and the courts are creating huge burdens on taxpayers and in many instances are forcing parents to lose their homes and to go on welfare. A generation of out-of-control teens from broken families and CAS group/foster homes are creating many social problems in our communities.

**Purpose of the meeting:** The purpose of the meeting will be to inform and educate the good citizens of Muskoka about very troubling developments affecting families in Muskoka and the significant abuse of tax dollars by child protection agencies and the family courts. At stake is the future of the very fabric of our community. Many believe because laws are being violated by child protection workers and officers of the court so blatantly that it strikes a blow at the heart of democracy and freedom in Canada. Children and families targeted by CAS workers are treated with less respect than convicted criminals.

**Who should attend:** Parents, grandparents, teachers, business owners and all persons in the region who are concerned about accountability, transparency and justice in our community are urged to attend this most important public meeting. This meeting is about the health of our community, about the health of families and about the abuse of our tax dollars by government funded agencies which fail to provide services to families in an accountable and fair manner. Those who attend can meet with other parents from the region with horrifying stories of how their families have been persecuted.

**Meeting details:** The meeting will be held on the evening of Monday November 8, 2010 at the Legion in downtown Huntsville located at 21 Veterans Way in Huntsville (Two streets East of Main Street) Doors open at 5:30 PM for refreshments. Lots of free parking available. Meeting and presentation will start at 7:00 PM. Question and answer period will follow the presentation with representatives from various parent groups there to answer questions.

During the public meeting and presentation, members of the public will learn about many of the unfair and unlawful acts being perpetrated against children and families by CAS and the family courts which many will find shocking. Over 90 children died while in the care of the CAS in one year alone, a number which Ontario's Child Advocate has said is shocking.

- ✓ Learn about how young children are being torn away from their loving families and friends by the CAS and the family courts! An update on the case involving the abuse of the three children from Huntsville by CAS workers will be discussed at the meeting.
- ✓ Learn how children are being forced on to mind-altering prescription drugs by CAS workers without the knowledge or consent of the parents.
- ✓ Learn about how taxpayer funded CAS workers and their lawyers use dirty tricks and lies to unfairly harm and disadvantage children and families in court proceedings.
- ✓ Learn about how CAS workers effectively silence children who are being abused so that CAS workers will not be exposed for their incompetence and lack of due diligence in protecting the children from abuse.
- ✓ Learn about how most CAS workers are unlawfully engaged in the practice of social work and openly breaking the law in Ontario by not being registered with the provincial body which regulates the practice of social work.
- ✓ Learn about how highly paid CAS workers in Muskoka took children on an unauthorized shopping trip to Walmart on our tax dollars when the children were supposed to be in school. CAS workers are supposed to be protecting children, not spending their time shopping at the expense of the taxpayers!
- ✓ Learn about how some children are being sexually exploited and physically abused by CAS workers themselves.
- ✓ Learn about how CAS workers turned young children over to a known criminal and heroin addict from Muskoka.
- ✓ Learn the shocking truth about how young children and teens are being sexually assaulted and physically abused while in the care of the children's aid society!
- ✓ Learn how children are being humiliated and their rights and freedoms violated at their schools by CAS workers who get away with breaking the law with impunity.
- ✓ Learn about how more children being taken away from families by CAS agencies means more tax \$\$\$\$ being paid by the province of Ontario to CAS agencies.
- ✓ Learn about how you or members of your family could easily be the next to be victimized and what you can do to protect children in our community.
- ✓ Learn how CAS agencies and the courts have become out of control and unaccountable to the citizens of Ontario and need to be reined in.
